
#### **Book Auction**

#### Halogen Lamps are Safe

(From the Australian Faceters Guild via the AFMS Newsletter, Nov. 1993)

The Minister of Justice and Consumer Affairs, Senator Michael Tate, has announced there is no danger in using tungsten halogen lamps of up to 50 watts.

Guild members will recall that last year an officer of the Australian Radiation Laboratory claimed skin damage could result from using tungsten halogen reading lamps for prolonged duration. The new report by Senator Tate, following an investigation, say: eight hours of exposure to a 50 watt tungsten halogen lamp is equivalent to five minutes exposure to sunlight! The minister's report added that exposure to halogen lamps resulted in the same ultraviolet emissions as similar forms of artificial lighting. For those who want to pick bones on the minister's statement, he went on to provide the following information: at 1000 lux (1000 candlepower per square meter or more than double the intensity of office lighting) UV radiation is approximately one percent of the equivalent UV radiation in sunlight.

At light intensities of 1000 lux, eight hours use of an unfiltered 50 watt lamp at practical working distances is approximately equivalent to five minutes exposure to sunlight.

Senator Tate went on to say that other than in exceptional circumstances, the use of unfiltered tungsten halogen desk lamps is assessed at practical working distances. He said desk lamps using tungsten halogen globes may exceed occupational limits of UV radiation at close distances and anyone with skin sensitivity to UV should avoid exposure to halogen desk lamps without filters. (AFMS Ed note: skin sensitivity may be significantly enhanced in persons taking large and sustained doses of aspirin as in the treatment of severe exacerbations of arthritis, and in persons taking oral methoxelen as in the treatment of psoriasis. For additional information, consult with your prescribing physician.)

#### Silver

I bought a ball of silver at the Montgomery club meeting in December. I had examined it and discovered quite a few small pieces loose in the bottom of the box which, upon examination with my loupe, appeared to be small fingers of silver crystals. Every time I picked up the ball, I could tell I was dislodging small bits of silver, so I carefully wrapped the specimen and paid for it then with no hesitation.

Immediately upon getting home, I placed the specimen under my microscope, and sure enough, the ball was made up of hundreds, maybe thousands, of tiny, dendritic or fern-like crystals of silver, and the bits and pieces loose in the box were exquisite little branches all ready to be mounted. I found that even my cactus needles were too large for most of the single leaves, but if I was careful and acted fast enough before the glue hardened, I could capture several bits of the silver on one needle and hide the point of the needle.

My real problem was how to preserve the mass of crystals and prevent the shedding of the crystal as the ball rolled around in the box. It was not possible to glue it down without forever ruining a large number of the beautiful bits of silver, and Mineral Tac was of no use either. Someone had attempted that method and had merely captured a layer of silver on the bottom of the box.

I described my dilemma to Fred Schaefermeyer, who suggested running pins through the sides of a box into the ball and suspending it in that manner with no parts of the silver ball touching the sides of the box. I found a box of long pins in the sewing machine drawer. The pins had white heads (balls) that were must perfect to keep the pin from going through the box. I heated the pin red hot in the flame of the gas cooking stove and quickly and carefully burned a hole through the plastic box on three sides. By carefully positioning the silver ball and impaling it on one pin at a time (the entire length of the pin penetrated the silver very easily), I now have the main specimen safely in a plastic box with the original label fastened to the box with Mineral Tac.

Since I have never seen silver crystals formed in a ball like this one, I am now trying to obtain information that will help explain how this many crystals formed in this manner. There is no other matter embedded with the silver and the crystals are not firmly packed, although the ball is rigid enough to feel quite solid when picked up gently.

I have a lifetime supply of tiny silver specimens in this one specimen and will gladly share with others who have interesting specimens and silver specimens in particular.

(The Editor of the Mineral Mite notes that the silver ball came from the Ura Mine, New South Wales, Australia.)

The Micromounters of New England meet regularly every month except for June, July, August, and December. Informal meetings are held in July and August. The May meeting is a pre registered event. Dates and locations of regular meetings are printed in the bulletin. Advance notice of the next month's meeting appears on the front page, lower left-hand corner. Arrival and departure times vary with each location but are not usually earlier than 9 AM and later than 5 PM. Members bring along microscopes, lights and minerals for study, trade and possible identification. Members provide their own lunch (except for the May meeting); the club provides coffee/tea. Dues are due on January 1st of each year, and are \$6.00 per member.


### EXECUTIVE BOARD MEETING
