Congratulations to MMNE member Gene Bearss of Sanford, and on his upcoming induction into the Micromounter's Hall of Fame (MMHoF) in September 2003. The amouncement was made officially at the Paul Desautels Micromount Symposium, which was sponsored by the Baltimore (MD) Mineralogical Symposium on September 13-15, 2002. Gene is entering the MMHoF under the status of "Modern" Micromounter (post 1939 activity).

It was a great honor for my dad, George, and I to submit Gene Bearss for consideration to the MMHoF Selection Committee in April of 2002. Initially, we had hoped to get the nomination in 2001, but when I had contacted MMHoF member Quintin Wight for information on the protocol for doing so, the deadline for nominations was just hours away and not feasible for 2001 consideration.

Many people contributed information that was used to compile the letter for Gene's nomination. Among them were Gene's long-time collecting partner Art Smith of Houston, TX, who provided us with some detailed information of Gene's accomplishments; Pat Barker and Norm Biggart, who provided an outstanding chronology of Gene's years in MMNE and many of his talks to other clubs in New England; Bob Janules, who supplied excellent material for some of Gene's published works; and Dr. Robert Jenkins, a Delaware member of the Franklin-Oglensburg Mineral Society, who was able to supply us with article references and copies of articles that Gene lad contributed to regarding collecting finds at Franklin, New Jersey.

Congratulations Gene and thanks for all of the work you have done in micro-mineralogy over the years.

CONTINUING THE REVISIONS OF THE BY-LAWS

MMNE members submitted the following comments and suggestions regarding the proposed changes which are included here with comments from the By-Laws Committee (BLC).

Article 2. Section 2.Insert "Candidates for" at the beginning of the second sentence. (BLC) Agree.

Article 2. Section 4. Comment: "What real good is it?" regarding honorary membership. (BLC) The Committee's thoughts are that it gives the MMNE a way to honor or say thank you to people who might not be micromounters but who have been staunch group might include museum directors, professional mineralogists, and dealers among others. As opposed to "Life" membership which includes a subscription to the Newsletter, honorary membership does not include a Newsletter.

Article 2. Section 5. "If you don't go (to the meetings), why are you getting the notice (newsletter) and voting". (Æd.) My thought are that there are a few people who have been members for many years, whose service to the club has been above and beyond simple membership activities, who deserve to be continued as members even if they no longer can participate.

Article 2. Section 5. Insert "in" before "arrears is last sentence. (BLC) Agree.

Article 2. Section 7. Comment: "Arrears too?" (BLC). As far as the committee is concerned the answer is "no", because as soon as they are in arrears they are not dues paying members.

Article 2. Section 9. Comment: "The time for this may be too short?" (BLC). There is no fixed time period for the process as the section is written...

Article 2. Section 10. Comment: "Something about the process of the renewal hearings should be stated." (BLC). This is not an easy issue to deal with, but the MMNE needs a mechanism for dealing with problem members both for expulsion and to deny renewal of membership. Perhaps we should follow the format of Article 2. Section 9., i.e., The Executive Committee may, at a regular meeting, recommend that the membership deny a request for membership renewal to any member who breaks the AFMS or EFMLS code of ethics or whose attitude or conduct is considered extremely detrimental to the welfare of the MMNE. Such a determination may be made only after the member has been given an opportunity to show cause why the denial of membership is not justified. A quorum of the Executive Committee must meet with the member prior to the regular meeting at which the denial is discussed and voted on. All members of the Executive

Committee must be notified by the corresponding secretary of the planned meeting with the member. (Comments please. This is new territory for the by-laws!!!)

Article 3. Section 6. Typo present and corrected.

Please read Article 9 dealing with the disposal of property should the MMNE disband. Our only asserts are whatever cash exists in the treasury at the time of disbanding, but there should be some defined place for this to go, preferable to a non-profit site, so that the Feds do not get it.

Articles 5 - 10 are listed with recommended changes starting on page 4. Please read these over and make any comments you wish. If the membership can iron out any major objections through the medium of the Newsletter, passing the revised set of by-laws at the annual April business meeting will be very short and quick.

PLEASE READ THIS

Most MMNE members are members of other clubs, however I am not. Therefore, I do not have easy access to other clubs' by-laws. We, the By-laws Committee, needs input from the membership regarding some particularly stickly issues in the revision of our by-laws, particularly strickly sections 9 and 10, and Article 9. If anyone can give us suggestions, or even copies of by-laws from other clubs, this process would be much easier for all of us.

The following is the second (and last) part of the proposed revisions to the by-laws.

ARTICLE 5 Meetings and Elections

Section 1. Meetings shall be held at such time and place as arranged by the President or member designated by the President to perform this function. [may be designated by the Program Committee.]

Comment: do we want to specify regular meetings in September, October, November, January, February, March and April with a symposium in May - and note possible additional meetings during the summer months?

Section 2. The annual business meeting for the election of officers and the submission of reports of officers and committees shall be held during the regular meeting in April or at any other time agreed to by a two-thirds vote of a quorum of the members, [members only shall be held prior to the regular meeting in the spring. Annual reports of officers and committees shall be given at this time.]

Section 3. A slate of officers [and one director] shall be published in the Newsletter and presented one meeting prior to the annual business meeting. Additional nominations from the floor may be made at this time followed by the oral acceptance of the nominees. [A ballot] An absentee ballot shall be made from these names and mailed via the Newsletter to every member to be returned to the recording secretary prior to the annual business meeting. Ballots both absentee and those cast at the annual business meeting, will be counted by a committee of two members who will report the results of the voting at the [annual] meeting.

Section 4. 10% of the members, but not less than 10 members, shall form a quorum for the purpose of elections or the transaction of business.

Article 6 Dues

Section 1. [The annual dues shall be four dollars, payable in advance.] Dues shall be payable on or before January 1st of each calendar year and shall not be prorated. The amount of the dues shall be adequate for the necessary expenses of the MMNE as demonstrated by the Treasurer's report, and shall be approved by a majority vote of the members when a quorum is present. Any change in the amount of dues will become effective on January 1 of the next calendar year.

Section 2. A member shall be considered in arrears if dues for the current year are not paid prior to [the annual meeting,] January 1st of the current year. There will be a 30 day grace period during which the member will not be relieved of duties as an officer or committee member, but the member will be considered to be in arrears during that time. No Newsletter will be sent to any member in arrears. All members will receive the January Newsletter since it will be mailed prior to January 1st.

Section 3. Renewal notices will be sent out with the November Newsletter with a reminder in the January Newsletter.

ARTICLE 7: Committees

Section 1. All standing committees shall be appointed by the Executive [Board] Committee. Standing committees are program, nominating, and membership.

Section 2. The number of members appointed to any standing committee shall be left to the discretion of the Executive [Board] Committee.

Section 3. Ad hoc committees may be created and members appointed by the president as necessary with simple majority approval of the Executive Committee.

Section 4. (This was moved from Article 5, Officers and their Duties) An audit [ing] committee consisting of two members appointed by the Executive [Board] Committee shall examine the books [previous] prior to the annual meeting.

ARTICLE 8: Amendments

Section 1. All amendments to, substitutes for, or alterations of the foregoing by-laws shall be proposed in writing and mailed to the membership via the Newsletter and discussed at the following meeting [and absentee ballots mailed to the membership for voting]. Amendments to, substitutes for, or alterations of the by-laws shall be voted on at the annual meeting. Absentee ballots shall be mailed to the active membership via the Newsletter at least 30 days prior to the annual meeting. No absentee ballot shall be counted unless it is received by the corresponding secretary prior to the annual meeting, it shall require a simple majority vote of the members, including absentee ballots, or a two-thirds vote of all cast ballots if a majority of the members have not yoted, to amend the by-laws.

Section 2. It shall require a two-thirds vote of [a mail ballot] the members to change the name of [this Club] the MMNE or to affiliate with other clubs or association. Any such proposed change shall be voted on only at the annual meeting. The active membership must be informed by mail of the proposed changes at least 30 days prior to the annual meeting and be supplied with an absentee ballot at that time.

ARTICLE 9: Disposal of MMNE Property and Assets.

If the MMNE disbands, all property and assets shall be turned over to ???

ARTICLE 10: Parliamentary Authority

The rules contained in Roberts Rules of Order, Revised shall govern [this Club] the MMNE in all cases to which they are applicable and are not inconsistent with these by-laws.
